A collaborative effort has restudied all of these laws and consolidated them into one Environment Code that was successfully approved last year and is now the legal basis for environmental management.

Today, we are learning more and sharing our best practices and challenges in the areas of air quality, sustainable wastewater management, biodiversity and climate change.
